Residents and tenants are jointly responsible for taking turns to clean stairs. Our staff inspect closes regularily & will update the inspection record on the ground floor landing with their findings & record any action taken.

## **Backcourts** - What is the Tenants/Residents responsibility?

BULK ITEMS	
DO	DONT
Place items at the side of the bin store for uplift on a Monday.	Put items inside the bin store.
Tie loose items together, i.e. laminate flooring, wood etc.	Leaveitems loose to be scattered over the back court. Cleansing won't uplift them.
HOUSEHOLD REFUSE	
DO	DONT
Tie and secure refuse bags.	Place loose items in the bin store. The Cleansing Department won't uplift items that are not bagged.
Place refuse bags in wheeled bins provided.	Do not leaverefuse bags outwith the wheeled bins or on the floor of the bins tore.
Put paint tins in tied secure bags and place in the bin store for up- lift.	Put out paint tins un-bagged as the Cleansing Department won't uplift them. This could also cause an increase in graffiti and vandalism in your area.

## GARDEN INSPECTION

If you have a garden, you must make sure you cut the grass and keep your garden tidy and free from litter. If you are not able to cut the grass you are responsible for making suitable arrangements to ensure that it is kept in a tidy condition. Our Housing & Neighbourhood assistants regularly inspect gardens during the growing season as part of their wider estate inspections to ensure that your area is looking at its best.

## **GROUND MAINTENANCE CONTRACT**

Our teams are busy throughout the year looking after your estates. In terms of this tenant rent funded service, ACHA prioritises the maintenance of the ground of areas which are in general closest to our tenants

## **ASSISTED GARDEN SCHEME**

If you are over 65 and/or are registered disabled and struggle to maintain your garden, you may qualify for the free grass cutting service. Please fill in the details opposite and either post it to your nearest ACHA office or hand it in next time you are passing. Addresses can be found on the back of this leaf

## **ESTATE INSPECTION**

We carry out Estate inspections on a quarterly basis across Helensburgh & Lomond. You are welcome to join our staff if we are in your area. Check the Estate inspection performance section on our website or contact your Area team to find out where they will be inspecting next.

## The common stair is your only means of escape in the event of a fire.



Have you ever thought what you would do if fire were to break out in your stair? It may not necessarily be in your flat! A fire started in a common stair could kill you and your family. Even a small bag of rubbish can create enough smoke to fill a whole stair. Items left in a common stair are often deliberately set on fire.

## **Keep it clear**

- · Get rubbish, old furniture, etc out of the building
- Make sure storage areas are kept locked
- · For advice on uplifting items contact your local Council

# If fire does start

- · Keep doors closed to prevent smoke filling your house
- Dial 999 and ask for the Fire and Rescue Service, giving as much information as you can

# ANTI SOCIAL BEHAVIOUR ADVICE

Nhat is antisocial behaviour

There is no precise definition of antisocial behaviour. Broadly, it is acting in a way that causes or is likely to cause alarm or distress to one or more people in another household. To be antisocial behaviour, the behaviour must be persistent.

There may be a fine line between antisocial behaviour and disputes between neighbours over relatively minor inconveniences, although these may, if persistent, become antisocial behaviour. Antisocial behaviour can include:

#### noise

shouting, swearing and fighting

intimidation of neighbours and others through threats or actual violence

harassment, including racial harassment or sectarian aggression. More about harassment

#### verbal abuse

bullying of children in public recreation grounds, on the way to school or even on school grounds, if normal school disciplinary procedures do not stop the behaviour

abusive behaviour aimed at causing distress or fear to certain people, for example, elderly or disabled people

driving in an inconsiderate or careless way, for example, drivers congregating in an area for racing

dumping rubbish

animal nuisance, including dog fouling

andalism, property damage and graffiti.
