Do you need some confidential advice on debt?

The national organisation, the Money Advice Service reported in February that an estimated 9 million people in the UK are in debt but shockingly only 20% of them are currently seeking help. Audrey said "Debt advice works and the earlier people get help the better their chance of a good outcome.

Are you affected by the spare room subsidy or Bedroom Tax, as it's known? If so then hopefully you've had assistance to meet the cost of your rent through the Discretionary Housing Payment (DHP) provided by Argyll and Bute Council. The Scottish Government has announced that an additional £15million will be made available in Scotland in 2014/15 for DHP's. Please make sure that you speak to local ACHA staff about this if you think you need to claim or re-claim in April.

It is hard to believe that in March of this year we reached the milestone of 10 years of ACHA. Although the Association took over the housing from the Council in November 2006, two years of planning, including winning the stock transfer vote, took place prior to that.

Looking back over the 10 years a lot has been achieved but there is a lot still to do. In terms of meeting the Scottish Housing Quality Standard for our homes, we have completed 82% of the work. This has resulted in over £100million being invested in the Association's 5,000 plus homes. We have also made considerable progress in



building new homes with over 170 built and over 100 on site in the coming year.

The Association over the years has added to the services we provide. This has included Welfare Rights, Allpay, grass cutting for elderly and vulnerable tenants and factoring and services for owners.

Challenges still lie ahead. With over 3,500 families and single people on the Home Argyll waiting list we need to build more homes. With huge challenges in relation to fuel poverty in Argyll and Bute we need to redouble our efforts to make our homes as energy efficient as we can make them. Lastly, the challenges around the Bedroom Tax and the development of the Universal Credit system continue to cause concern to the Association in terms of the wellbeing of many of our tenants.

The first 10 years have gone by very quickly. The next 10 will be about building on what we have achieved and continuing to meet housing need in all its formats.

At the end of March we were 82% compliant with the Scottish Housing Quality Standards having spent over **£93 million** on improvements to your homes.

Another 102 new homes will be on site by April:

- 40 new homes Glenshellach, Oban
 - 2 new homes Bonawe
 - 8 new homes Connel
- 20 new homes Bowmore, Islay
- 12 new homes Inveraray
- 8 new homes Tarbert
- 12 new homes Helensburgh

The new HOME Argyll Allocations policy is due to be finalised in July 2014.



Last year we introduced a new service to help you if you wanted to exchange or swap your home. A mutual exchange, or swap, not only offers you a better choice for finding a new home, it could be a guicker option than waiting for a move on our transfer list. HomeSwapper is easy to use and automatically matches you with tenants who are interested in your home and have a home that you may be interested in. All you need to do is register at www.homeswapper.co.uk. and you can add up to nine photographs of your home. When your registration has been approved, you will be able to access information about tenants who may wish to exchange properties with you. Tenants Charter update



We have been working on the report to the Scottish Housing Regulator called the Annual Report on the Charter (ARC). The ARC will contain performance information on the 16 areas of the Charter and will be given to the Regulator in May of this year.

In October we will publish a report on the outcomes and this report will be produced with the assistance of the tenants and other customers who are part of the 'Your Voice' Group. If you would like any more information please contact your local ACHA office.

Right to Repair - under the Housing (Scotland) Act 2001 tenants have the right to have small (up to £350), urgent, repairs carried out within a given timescale. These are known as 'Qualifying Repairs'. When you report a repair we will let you know whether it is our responsibility and whether it is a qualifying repair. We may need to inspect your home to find out. If the repair does qualify under the scheme, we will explain your rights under the Right to Repair scheme and advise you of the time allowed to carry out the repair. In some circumstances we may be unable to do the work in the allotted time but we will advise you of this and make temporary arrangements. Included with this newsletter is an insert all about Right to Repair and there are leaflets in all our offices.



We asked you what you think about ...

ACHA consulted with all tenants during January of this year on the proposed rent increase of 4.35% for 2014/2015. All tenants were sent out a booklet in January which explained the current circumstances and asked for comments and feedback.

We received 88 responses to the consultation and these responses were given to the ACHA Board when it considered the rent increase and the implications for ACHA's 30 year business plan at its meeting on 12th February.


After careful consideration, the Board approved an increase of 4.45% which is (RPI +1.75%) RPI = Retail Price Index. This took effect from 1st April 2014.

Each year we ask our Sheltered Housing tenants a number of questions about the service they receive and the response to our 2013 survey was particularly positive with 92.7% of those responding (111 surveys) rating their experience of living in Sheltered Housing as excellent or very good.

If you want to move house because of the Bedroom Tax, read on...

Just under 500 tenants are affected as they are deemed to have more bedrooms than they need. Over the last year staff have assisted tenants to claim Discretionary Housing Payments (DHP's), with debt management and with applications to move to smaller properties. Last July our Board of Management agreed to a number of temporary changes to policies to assist tenants (affected by Bedroom Tax) to move house. This included the award of additional points to help facilitate an early move to another house. These additional points will only be available up to 30th June 2014 after which normal points as per the HOME Argyll Allocation Policy will be applied. If you, or anyone you know, are affected by the bedroom tax and need advice on Benefits or moving house, please get in touch with staff at your local ACHA office.
